(c) The Total Annual Bill and Total Monthly Bill include the base charges from Atlanta Gas Light Company. The annual base charge for a typical customer with a 1.29 DDDC Factor is \$258.85 and is \$84.83 for qualifying senior citizens. The April 2010 base charge is \$21.00 for a typical customer with a 1.29 DDDC Factor, and is \$6.30 for qualifying seniors with a 1.29 DDDC Factor.
